Founded by Thomas Felsberg, the firm has always had an innovative spirit at the core of everything it does.

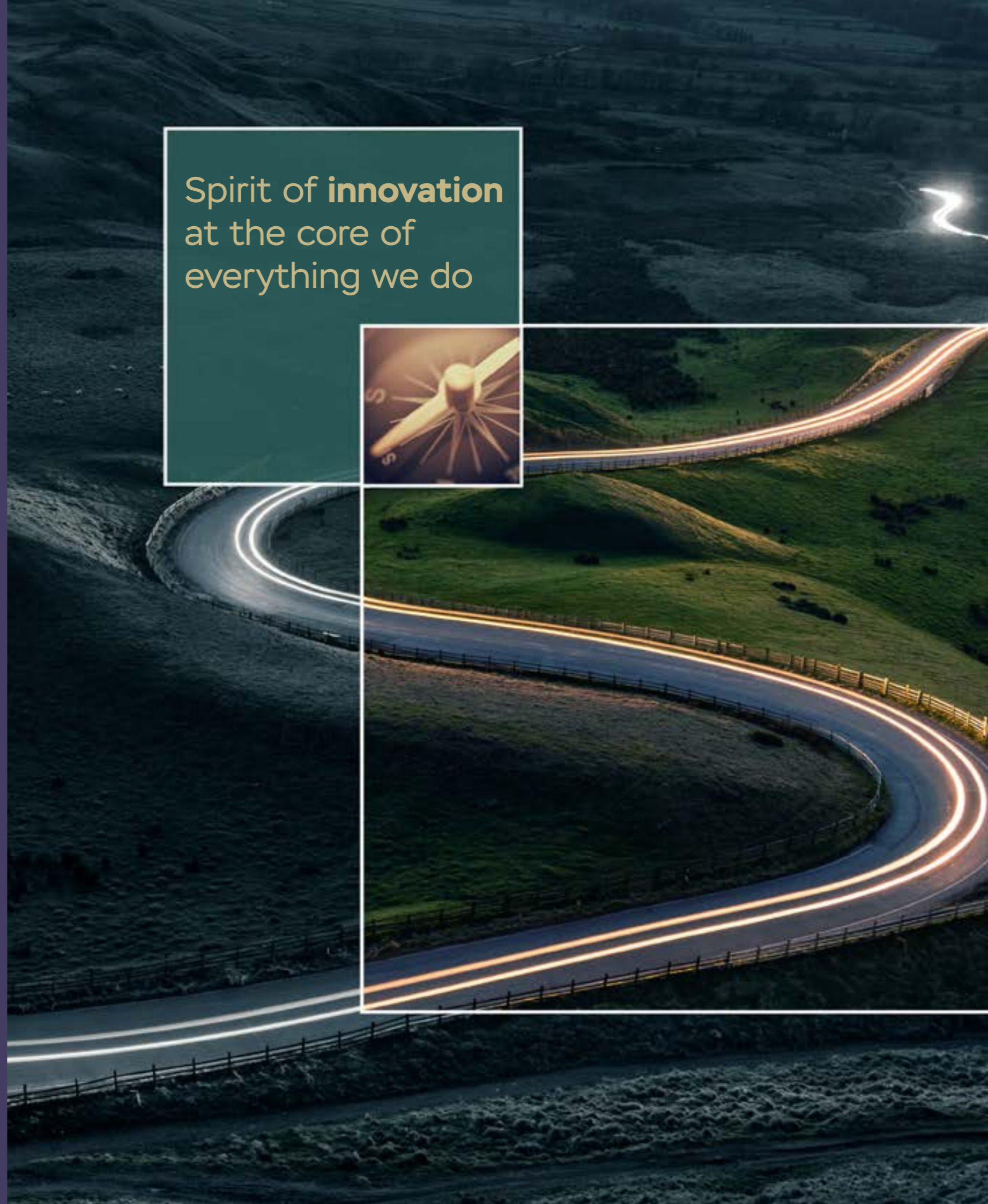

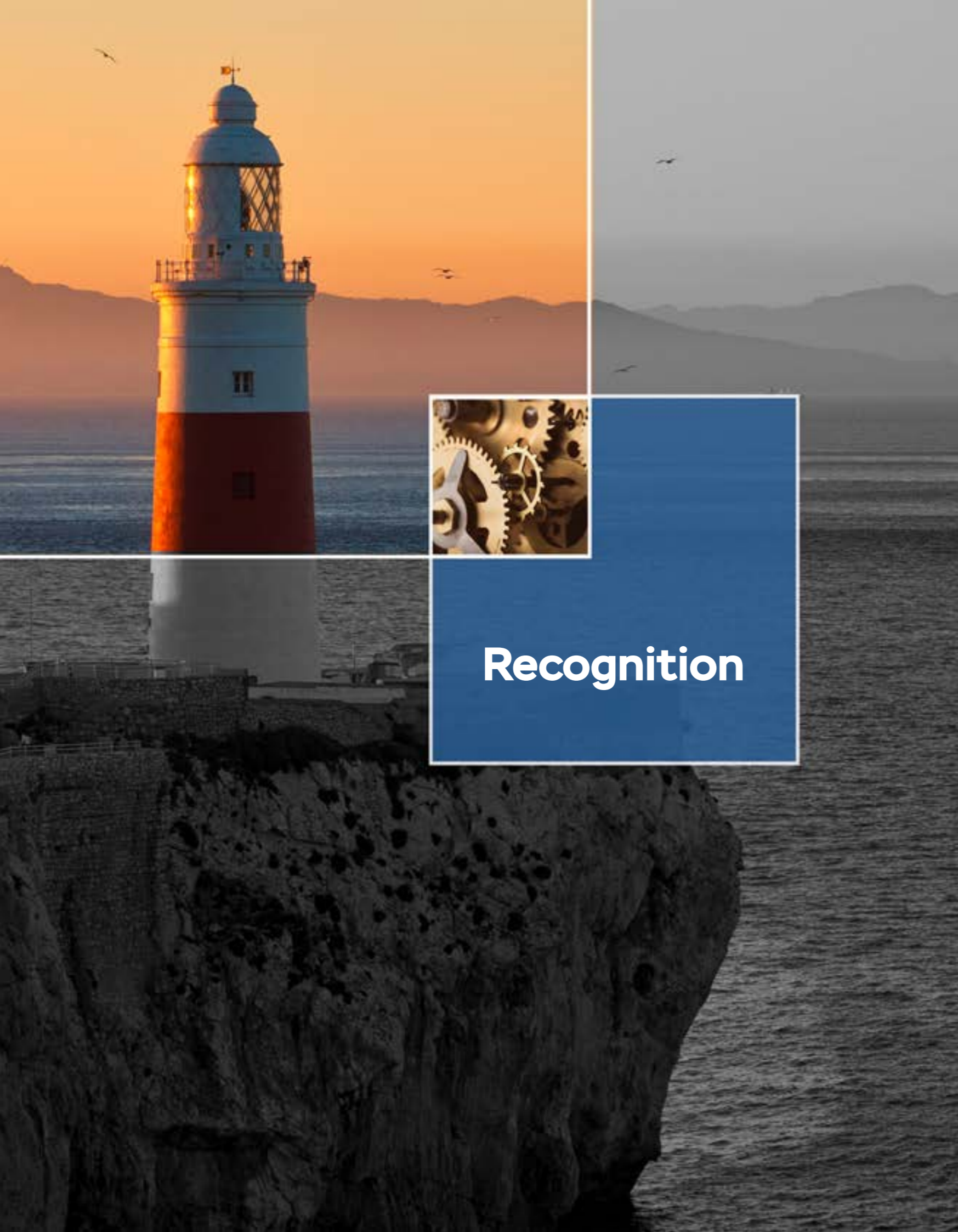
The Committee aims to promote initiatives and regular events to raise awareness and encourage reflection on relevant and necessary topics for a more respectful society.

Corporate

Foreign investments

We also make the necessary arrangements for the formalization of such investments, including the declarations required by the Brazilian Central Bank, and the drafting of documents for the formalization of loan transactions and remittances of capital into or out of Brazil.

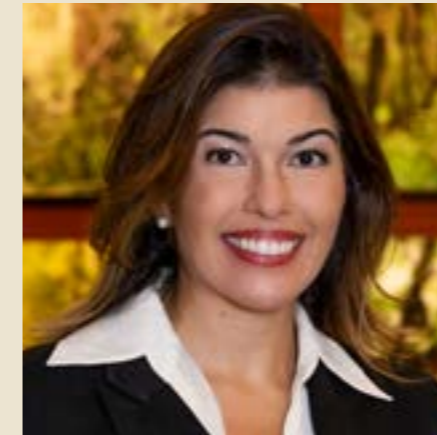

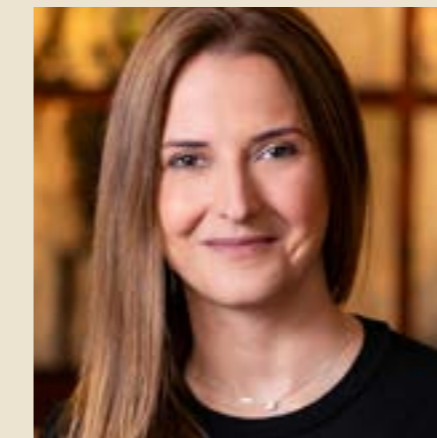
